At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 13<sup>th</sup> day of December, 2011, at 7 o'clock Eastern Standard Time.

The following resolution was made by Cook and seconded by Sheridan:

WHEREAS on April 11, 2006 the Birch Run Township Board of Trustees adopted the Birch Run Township Cemetery Ordinance #2006-02, and on September 9, 2008 amended the Birch Run Township Cemetery Ordinance #2006-02, and

WHEREAS, the Birch Run Township Board of Trustees periodically review the fee schedules surrounding the administration of burials and the maintenance on the Birch Run Cemetery ensuring the fees schedule is current, and

THEREFORE, BE IT RESOLVED, that the Birch Run Township Board does hereby adopt the following fee schedule for establishing the proper fees for the Birch Run Township Cemetery:

**Cemetery Fees:**

Graves per space: \$400.00

Nonresidential cost per lot: \$800.00

Columbarium Niche Residents: \$300.00

Columbarium Niche Non-Residents: \$600.00

Adult Burials: \$550.00 (Includes machine time)

Child Burials: \$250.00 (Burial in Special "Child" Section only)

Cremation Ground Burial: \$100.00

Cremation Placement in Columbarium Niche: \$50.00

Chapel Use: \$50.00 (Required between November 1<sup>st</sup> and March 31<sup>st</sup>)

Machine Time: \$50.00 per hour

Extra Man: \$10.00 per hour.

Sunday and Holidays: \$75.00 more
