AND THE MICHIGAN STATE POLICE TO CONDUCT A SPEED STUDY ON EASTBOUND
BIRCH RUN ROAD BETWEEN ELMS ROAD AND THE VILLAGE LIMITS IN BIRCH RUN

At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 8th day of December, 2009, at 7 o'clock Eastern Standard Time.

PRESENT: Cook, Kiessling, Marr, Nelson, and Magnus

ABSENT: Trevino and Strahm

The following resolution was made by Marr and seconded by Nelson:

WHEREAS, this eastbound stretch of Birch Run Road enters the Birch Run Village Limits; and

WHEREAS, the speed limit on the eastbound section of Birch Run Road decreases dramatically from 55 miles per hour to 25 miles per hour; and

WHEREAS, said sudden speed limit decrease causes a dangerous traffic situation for the residents of this eastbound stretch of Birch Run Road as well as for through traffic;

NOW THEREFORE BE IT RESOLVED, that the Birch Run Township Board is formally requesting the Saginaw County Road Commission (SCRD) to conduct a speed study on eastbound Birch Run Road from Elms Road to the Birch Run Village limits in order to examine the feasibility of a gradual decrease in posted speed limits. It is understood that the SCRC in cooperation with the Michigan State Police (MSP) will use engineering data gathered in this speed study to make a decision which could raise, lower, or maintain the current speed limit. It is further understood that Birch Run Township will abide by the decision made by SCRC and MSP as a result of this speed study.
