RESOLUTION TO ESTABLISH TOWNSHIP OFFICERS SALARY
2002-01

At a Regular Meeting of the Township Board of the Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 12TH day of February, 2002, at 7 o'clock Eastern Standard Time.

PRESENT: Putnam, Cook, Schlegel, Trevino, and Stewart

ABSENT: Magnus and Strahm

The following resolution was made by Stewart and seconded by Putnam:

WHEREAS, Michigan Compiled Law 41.95 authorizes the township board of Birch Run Township to determine the salaries for the offices of supervisor, clerk, treasurer and trustee for fiscal year 2003 by adopting a resolution at least 30 days prior to the township annual meeting, and

WHEREAS, on February 12, 2002 the township board adopted a resolution to hold the township annual meeting on March 26, 2002, and

WHEREAS, the township board deems that adjustments in the salaries of these elected township officials is warranted in consideration of the increase in the cost of living and additional responsibilities undertaken by these officials since township board members; salaries were last adjusted, now

BE IT RESOLVED, that is as of April 1, 2002, the salary of the township board member shall be as follows:

Supervisor: \$16,000 exclusive of assessing duties.

BE IT ALSO RESOLVED, that this resolution shall be submitted to the electors at the annual meeting to be held on March 26, 2002 at which time the electors may modify this amount. Pursuant to MCLA 41.95(7), such modification(s) that may be made by the electors cannot result in a reduction of salary during each official's term of office. In event that the electors fail to act on this resolution, the officer shall be entitled to the salary as established in this resolution, in accordance with state law.

BE IT FURTHER RESOLVED, that this resolution, adopted this day February 12, 2002 is properly adopted by the Birch Run Township Board at least 30 days prior to the annual meeting, as required by law.
