

REGULAR MEETING JANUARY 9, 1990

Motion by Totten, supported by Foerster to order a special meeting of the electors of Birch Run Township to be held at 7:30 p.m. on Jan. 29, 1990 at the Marshall Greene Middle School, 8225 Main St., Birch Run for the purpose of seeking authorization to purchase 50 acres more or less to be used for the relocation of Buster Brown Community Park from Fremont and Silvila Schian at a cost of \$100,000 plus an addendum requiring the renaming of the park to Shcian addition to Buster Brown Community Park.
