At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 13<sup>th</sup> day of July, 2010, at 7 o'clock Eastern Standard Time.

The following resolution was made by Magnus and seconded by Nelson:

**WHEREAS**, Section 53b of the General Property Tax Act, MCL 211.30, requires the July and December Board of review to meet on the first Tuesday following the 3<sup>rd</sup> Monday in July and December, and

**WHEREAS**, assessors who work for multiple townships are not always able to attend the Board of Review meeting for each township when they meet on the same day; and

**WHEREAS**, State Tax Commission Bulletin No. 8 dated October 27, 2008, allows a governing body to authorize an alternative starting date for the July and December Board of review meetings, which can be set on an alternate day during that week; and

**WHEREAS**, it will benefit the residents of Birch Run Township to have the assessor available to assist the Board of Review and taxpayers in processing tax appeals and poverty exemptions;

**NOW, THEREFORE, BE IT RESOLVED** that the Wednesday following the 3<sup>rd</sup> Monday in the month July and the Wednesday following the 2<sup>nd</sup> Monday in December has been selected as the alternative starting dates for the July and December Board of Review meetings.
