## (Resolution Designating Special Assessment District)

At a special meeting of the Township Board of the Township of
Birch Run, Saginaw County, Michigan, held at the Township Hall on
the 26th day of April, 1994, at 7:00 o'clock p.m. Michigan Time.
PRESENT: Magnus, DiBerardino, Russell, Strahm, St. Charles, Hayes
ABSENT: None
The Supervisor announced that this was the time fixed for
hearing and considering any objections to the construction of a
water main in said Township located as follows:
An 8-inch water main measuring 909 feet located beneath the Dixie Highway in the vicinity of Maple Road, to be connected to the current water main located adjacent to the Dixie Highway, together with the installation of one fire hydrant.
and to the special assessment district as tentatively established
for said water main improvements by the Township Board.
No written or oral objections were received except as
follows:
The supervisor then declared the hearing closed.
The following resolution was offered by Russell and
seconded by <u>Hayes</u> :
WHEREAS, the Township Board has tentatively determined,
pursuant to the provisions of Act No. 100 of the Wichigan Dukate

Acts of 1954, as amended, to construct a water main in the Township

to be located as described above.

WHEREAS, this Board has met on this date for the purpose of hearing and considering any objections to the improvement, and to the special assessment district tentatively established for the improvement.

THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF BIRCH RUN, SAGINAW COUNTY, MICHIGAN, as follows:

1. That this Board does hereby designate, as the Maple Road Water Line Extension Special Assessment District, against which the cost of the improvements are to be assessed, the following lands in the Township.

A part of the W 1/2 of the SW 1/4 of Section 8 described as follows: Commencing at the W 1/4 post of Section then S 0°29'10" E 1049.59 feet along W section line to the centerline of Dixie Highway then S 29°31'40" E 277.13 feet along said centerline thence N 60°28'20" E 1373.97 feet perpendicular to centerline of Dixie Highway to W 1/8 line thence N 0°30' W 634.13 feet to 1/4 line then S 89° W 1335.62 feet to Point of Beginning, except commencing at W 1/4 corner then S 894 feet to Point of Beginning then E 300 feet thence S 126.52 feet thence S 61° W 48.89 feet thence W 256 feet to centerline of Dixie Highway then N 28° W 2.59 feet to intersection of said centerline with W section line then N 147.73 feet to Point of Beginning, Tlon R6E.

- 2. This Board hereby approves the plans and cost of \$27,000 for the improvement as prepared by Bartow & King, registered professional engineers, which has been submitted to this Board.
- 3. This Board hereby determines to proceed with the above described improvement.
- 4. The Township Supervisor is directed to make a special assessment roll which assesses the cost of the improvement in a sum

not to exceed \$27,000 against the lands in the special assessment district. The roll shall include the names of the respective owners of the lands in the district, if known, and the total amount of the special assessment shall be such relative portion of the whole sum to be levied against all the lands in the special assessment district, as the benefit to each parcel of land bears to the total benefit to all parcels of land in the special assessment district.

5. When the Supervisor has completed the special assessment roll, he shall affix his certificate to it, as required by law, and report the same to this Board.
